## DPHSS Guidance Memorandum 2020-21

RE: Additional Businesses and Organizations Authorized to Operate during PCOR 2

This document supplements DPHSS Guidance Memoranda 2020-01 (March 19, 2020); 2020-02 (March 28, 2020); 2020-05 (April 8, 2020); 2020-07 (May 7, 2020); 2020-08 (May 15, 2020); 2020-10 (May 27, 2020); 2020-12 (June 10, 2020); 2020-14 (June 6, 2020); 2020-15 (June 6, 2020); 2020-16 (June 6, 2020); 2020-17 (June 6, 2020); 2020-18 (June 10, 2020); 2020-19 (June 13, 2020); and 2020-20 (June 13, 2020). The purpose of this document is to list additional businesses that have been authorized to operate during Pandemic Condition of Readiness Level 2 (PCOR 2), which was declared by *Maga'hagan Guåhan* Lourdes A. Leon Guerrero on May 10, 2020.

### APPROVED FOR OPERATION DURING PCOR 2:

1. All business operations and business activities during PCOR 1.
2. Businesses and Organizations Approved for Operation at Declaration of or during PCOR 2.
3. Additional Businesses and Organizations Authorized to Operate during PCOR 2 beginning on Friday, June 19, 2020 at 8:00am:
  - a. Bars and Taverns at 50% occupancy rate;
  - b. Childcare center facilities at not more than 50% of child enrollment;
  - c. Bowling alleys;
  - d. Travel agencies;
  - e. Museums;
  - f. Zoo; and
  - g. Aquariums.

The businesses and organizations identified under Item 3 may proceed to operate after industry-specific or organization-specific plans are developed and submitted with COVID-19 prevention and control measures outlined in the document, *Minimum Pandemic Workplace Operational Requirements*, which was issued by the Department of Public Health and Social Services and any other requirements set forth by DPHSS. **ENFORCEMENT OF PUBLIC NUISANCES:**

Any business which fails to operate consistent with applicable and current Executive Orders and/or Public Health Guidance shall be deemed a public nuisance under Chapter 20, Title 10, of the Guam Code Annotated. Further, the DPHSS Division of Environmental Health (DEH) *shall* consider such public nuisance as a violation of the conditions of the business' sanitation permit. If a business is found to be in violation, DEH *may* revoke or suspend the permit in accordance with Guam law and regulations.
